### REPORTS

- **Budget Preparation:** Philip Carroll, CFO, and Janice Sykora, Interim Supt., presented an update on utilizing the Budget Development Calendar, fiscal year 2022-23.
- **Dress Code Policy:** The Board discussed the first reading of policy FNCA (Local). Campus principals will work with their site-based team to determine elementary and secondary level dress codes for 2022-23.

### ACTION ITEMS

The Board of Trustees took the following actions:

- Hired Steve VanMatre as TMISD superintendent who reports to TMISD on June 6, 2022. Welcome, Mr. VanMatre!
- Approved Bill Wilson as the architect of record for food service renovations.
- Approved to increase district's monthly contribution toward employee health insurance from \$275 to **\$300** beginning 9/01/22.
- Approved the District of Innovation (DOI) Plan effective from April 25, 2022, to April 25, 2027.
- Named the NJROTC firing range in honor of Felix Landin, Jr., former TM Board Member.

- Approved stipends for teacher shortage areas effective 7/01/22. To be eligible, the teacher must have a valid Texas teacher certificate in the teaching assignment and be assigned to teach in that subject area. The stipend will be paid in 12 equal payments.
